You, as Consumer hereby expressly acknowledge that the present Conditions are applicable for the "LG 5 years warranty for refrigerator" campaign, You accept it as the one binding for you, and you understand that the connected rights are solely to be enforced according to the Conditions.

- 1. Based on the present Conditions, the document verifying your purchase (invoice, simplified invoice, receipt), the filled-in warranty card and the downloaded document of 'Certificate of 5 year warranty for refrigerator' are jointly required to apply the "LG 5 years warranty for refrigerator" for your Product purchased during the campaign period.
- 2. The certain matters defined in the Conditions have no effect on Your rights, as a consumer, enforceable based on any laws and regulations.
- 3. The "LG 5 years warranty for refrigerator" grants you the following rights and advantages:

During the 5 (five) years calculated from the original purchase date of the Product, there is a fullscope expressed warranty for all defects which are the result of manufacturing mistake, which means free of charge repair, free of charge spare parts and free of charge on-site repair, if on-site repair is needed. Furthermore, this includes eventual free of charge replacement of the Product, as well. If the Product needs to be replaced during the term of the "LG 5 years warranty for refrigerator" (even more than once), you will be entitled to the statutory warranty conditions applicable at the time of Product replacement, or to the expressed warranty terms and conditions based on the present Conditions applicable until the expiration of the original term of the "LG 5 years warranty for refrigerator" of your originally purchased Product, whichever is more beneficial for You, as a consumer.

- 4. The "LG 5 years warranty for refrigerator" is valid for the period of 5 years calculated from the date of purchase, and is to be extended each time when the Product is out of order due to the defect with the time period of such out of order period.
- 5. Each and every repair or replacement will be noted on the warranty card issued by LGEMK during the 5 years period.
